#### General Information

- Event will begin at 8:00 a.m. on Saturday and Sunday for all ages. **WE ARE ON THE EASTERN TIME.** Gyms will be open 45 minutes prior to start times. An Entry fee will be required this year.
- \$3 Adults - \$5 2 Day Pass
- \$2 Students & Seniors - \$3 2 Day Pass
- Free – Children 7 and Under
  
- All matches will be best two out of three sets to 25 points, rally score, no cap. If 3<sup>rd</sup> set is required it will be to 15 points, rotate at 8, no cap. The 15s and 16s Bronze bracket will play a 3 team pool of three 25 point games.
  
- Team shall provide down official, line judges, and score keepers when the team is scheduled to officiate. Coaches must sign the scoresheets following matches.
  
- Libero rule is in effect. Libero will be permitted to serve.
  
- Only registered USAV members can be on the floor.
  
- All Pioneer region and USAV rules will be in effect.
  
- A protest committee comprised of Mark Tullis or his designee (Referee Chair), Dennis Smith (Kenton Volleyball Club) or Brian Jackson (Kenton Volleyball Club) will resolve any and all disputes that may arise during play.
  
- No coaches meeting. Tournament packet will be picked up at team's first playing location.
  
- Hospitality room is provided for all coaches, directors, and officials at each facility.
  
- **NO COOLERS ARE PERMITTED INSIDE ANY FACILITY. Failure to follow this rule will result in the team being removed from the tournament. Each facility will have a full compliment of concessions.**
- **Chairs are needed/required at Simon Kenton High School.**

#### Additional Information

#### **Warm up/Penalties:**

- Minutes for the first match of the day (2-4-4)
- Minutes for the third match of the day (2-3-3-1)
- Team will forfeit match after 13 minutes late of schedule start time or time designated if previous match goes beyond schedule time.
- All matches will be 2 out of 3 games. First 2 played to 25 points (win by 2) and third game to 15 (win by 2).
- Wave format play may begin before scheduled times.

#### **Tie breaking procedures:**

- Head to Head, Match Record, Set Winning Percentage and Points. Tie breaking game to 15 points: will only be played when the tie cannot be resolved and it affects the Gold Bracket advancement.

#### **Officiating responsibilities/Penalties:**

- Team late for officiating responsibilities will forfeit 1 point for every minute late and applied against them in their next schedule match of the tournament.
- Team that does not show up at all for their assigned officiating responsibilities will forfeit their next schedule match of the tournament. They will also be reported to the Pioneer Region or respective Region.
- Team that does not fulfill their officiating responsibilities after they have been knocked out to the tournament will be reported to the Pioneer Region or respective Region, will not be allowed back into future year's Outback Kangaroo Classic tournaments and will be fined \$100.00.
